

# Ouachita Christian School

## 2026-2027 FINANCIAL INFORMATION

### (1) FAMILY ENROLLMENT FEE (Non-Refundable) . . . . . \$425.00

For currently enrolled families, this yearly enrollment fee is due **March 1<sup>st</sup>** for the following school year. Failure to pay this fee by the March 1<sup>st</sup> deadline will release OCS from any obligation to hold positions in classes and/or grades and will allow the School to offer those spaces to students on the waiting list. This fee is non-refundable.

**The enrollment fee for currently enrolled families increases to \$475 after March 1<sup>st</sup> and to \$525 after May 1<sup>st</sup>.**

### (2) TUITION:

General Tuition covers basic instructional costs excluding the specific fees detailed below. A yearbook will be given to each student as a part of the tuition structure.

The discounted annual payment must be received by July 31<sup>st</sup>. **Parents must create an online FACTS account and choose a payment plan.** Students enrolling after the beginning of an academic year will be charged General Tuition on a prorated daily basis and the number and the amount of monthly payments will be adjusted based upon the enrollment date.

### (8) TESTING FEES:

- AP Testing fee (Due May 1st ) . . . . . \$100.00
- This is a testing fee for AP classes. It is billed when applicable
- PreACT/PSAT (Due Dec.1<sup>st</sup>) . . . . . \$20.00

**(9) DUAL ENROLLMENT FEE** – Students who enroll in OCS classes with college credit will have additional charges. The ULM/LA TECH Application and Enrollment Fees (per class) depend on the university’s billing structure and will be due after the class begins.

### (10) FOOD SERVICE:

OCS partners with Lexington Independents to provide breakfast and lunch options at ***The Table***, our cafeteria.

### (11) AFTER-SCHOOL PROGRAM:

An After-School program is available for all students in grades PreK – 8th grade. The cost is \$7.00 per day and this charge is added to the student’s account and billed monthly.

### (12) SECURITY FEE:

A \$125 security fee will be collected for all students to ensure that OCS has exceptional security measures in place.

### (13) BUS TRANSPORTATION (Due according to selected payment plan):

Students/families riding only **one-way** each day will be charged \$90 per year less than the above rates.

### (14) FACILITY FEE:

A \$100 facility fee will be collected for all students to ensure that the facilities at OCS are upkept and safe for everyone.

# TUITION and FEE INFORMATION

2026-2027

1. The **ANNUAL FAMILY ENROLLMENT FEE** will be due for returning families on March 1<sup>st</sup> of each year. This fee is non-refundable.
2. **GENERAL TUITION** pays for basic instructional cost not covered by other fees. A yearbook will be included for each student as a part of the tuition structure.
3. **CLASS DUES** - In the **elementary and middle school**, these fees are used for instructional activities and field trips/service opportunities. Money (except lunches) is not collected during the school year. At the **high school level**, these fees are used for class activities/supplies and other class specific responsibilities (homecoming, junior/senior banquet, service projects, senior group portrait, etc.).
4. The **BOOK/TECHNOLOGY/SUPPLY FEE** covers textbooks, paperbacks, expendable workbooks, and other classroom instructional supplies. Books which are lost or damaged must be replaced at the **current replacement cost**. This fee also covers the use of technology on campus, mobile textbook apps and software licenses.
5. The **CHROME BOOK DEVICE** fee provides each student the personal use of a chrome book on and off campus during the school year. Only one device fee is due during the student's 7<sup>th</sup> – 12<sup>th</sup> grades at OCS.
6. The **CHROME BOOK INSURANCE** fee is due every year. This fee will cover the maintenance of the student's chrome book and provide replacement if it becomes necessary. It does NOT cover lost or abused chrome books.
7. The **STUDENT "EAGLE PASS"** is required for grades 1-12. Students may use their OCS Student ID (or a picture of it) for admission to all home, regular season games.
8. The **ADVANCED PLACEMENT FEE** is for the cost of the Advanced Placement test. This fee will be billed to Juniors and/or Seniors in AP classes only. The **PSAT** testing fee is billed to all Sophomores and Juniors who take this achievement test.
9. The **DUAL ENROLLMENT FEE** applies to the cost of the book/software for OCS and the ULM, LA Tech, and/or Delta charges for the transcript credit. Each dual enrollment course will be charged this fee. All seniors and honors juniors will be taking dual enrollment math. First time students to ULM/LA Tech will also be charged an application fee.
10. **FOOD SERVICE** is optional. Every student will be assigned an account with Lexington Foods at the OCS cafeteria, The Table. Breakfast and lunch options are available each day. To use the account, parents can set up online access to monitor spending and/or automatically load funds. They can also send cash or checks made payable to "Lexington Foods" to fund the student's pre-pay account or pay cash each day.
11. **AFTER-SCHOOL Program** is available each school day from 2:45 pm – 5:30 pm. After 5:30 pm, a fee of \$10 per minute per child will be added to your bill.
12. **SECURITY** – is required for all grades. This fee will ensure OCS can take exceptional security measures for student and staff safety.
13. **BUS TRANSPORTATION** - Please sign up for bus transportation during the enrollment process.
14. **FACILITY FEE** – is required for all students to ensure safe and upkept facilities for all.

## NEED – BASED FINANCIAL AID

There are two types of financial aid available. Both programs are based on financial need and availability. A new application is required each year. The Financial Need Program is available to students in any grade who have been enrolled for at least one year. Applicants to the Financial Need Program may receive 10% in tuition aid. The deadline for applications is May 1st for the following school year. Minority students in grades 6 – 12 may apply for the Minority Aid Program (MAP). Eligible applicants may receive 10% - 50% aid, based on the family income level. Applications for MAP are accepted year-round. The deadline for re-application for MAP applications is June 1st for the following school year.
